Purpose of the Contest Weekend and Titleholder

This Contest and Weekend are designed to be fun and entertaining to people involved in the Leather, Bear, Fetish and BDSM communities. The Weekend is full of events to provide a true Leather experience to the participants. The titleholder will provide information, support and community service around Albuquerque as well as at local, statewide and national events.

The New Mexico Leather Bear and cub Contest is open to anyone who is involved in the Bear, Leather, Fetish and/or BDSM communities. The winners are chosen based on criteria that are listed below. The Contest provides a venue that allows all participating leather/kink/BDSM folks to present a positive leather image.

The winners must be intelligent, articulate, quick-witted, capable of communication and outreach to bear, leather and non-leather communities. They must represent the leather and bear lifestyles as positive role models. The titleholders are the representatives of Mr. New Mexico Leather Bear and Cub and the Albuquerque Leather Daddys wherever they go. The winners also serve as representatives of the Bear, Leather, Fetish and BDSM communities in both physical appearance and actions, and will serve as spokespersons. The winners will each receive a prize basket donated by sponsors, as well as a patch from the Albuquerque Leather Daddys. The winners are also expected to participate in community events, fundraisers and special functions to benefit the Bear and/or Leather communities as well as the community at large. As Mr. New Mexico Leather Bear and cub, the winners may be expected to speak to groups and individuals about human rights and responsibilities around safe, sane and consensual sexual behavior. Titleholders are also expected to promote the stated purpose of each title.

Eligibility Requirements

Each contestant is required to:

- Be at least 21 years of age,
- Be known and active in their local Bear, leather, fetish or BDSM community,
- Be a resident of the United States of America,
- Own the leathers or other clothing/costuming which he wears in the contest,
- Follow the legal guidelines of the State of New Mexico, Bernalillo County and the City of Albuquerque,
- Complete and sign the "Contestant Application Form" and Image Release Form" allowing photos and information of them to appear in the media (pseudonyms are

acceptable for media release. However, legal names must be used on the "Image Release Form" and will be kept private upon request),

- Participate in all levels of the judging for the contest and to appear on time at all related sponsored events during the Contest weekend,
- Appear at the step-down ceremony at the next year's Contest and award the new titles to their successors, and
- Agree NOT to compete in any other contest during their reign without prior approval from the Producers of Mr. New Mexico Leather Bear and cub Contest.

Contestants in the contest may, but are not required to be, sponsored by an organization or business.

Standard of Conduct for Contestants and Titleholders

All contestants, runners-up to the title and titleholders are required to uphold a reasonable standard of conduct. This standard includes, but is not limited to, not being or appearing to be intoxicated in public while acting in an official capacity; not using or selling illegal substances; treating all persons with courtesy and respect; being responsible, punctual and accountable for all commitments and refraining from slander or ridicule regarding individuals, Mr. New Mexico Leather Bear and cub Contest, the Albuquerque Leather Daddys or any of its events, or any other contests or events.

Mr. New Mexico Leather Bear and cub Contest Producer (the Albuquerque Leather Daddys) may at its discretion, remove the Mr. New Mexico Leather Bear or cub title or that of any runner-up for failure to perform his duties or for any other violation of the standards of conduct or responsibilities a set forth above. If Mr. New Mexico Leather Bear's or cub's title is removed, the Producer may ask the first runner-up to serve in his or her place as titleholder for the balance of the year.

Should Mr. New Mexico Leather Bear's or cub's title be removed, all prizes awarded to that person, including the patch, medallion, etc., shall be returned to Mr. New Mexico Leather Bear and cub Contest within seven (7) days or further action will be taken, including legal avenues.

Scoring

A maximum of 900 points can be awarded by each judge. The final scores will be a cumulative total of all the judges' score sheets. Olympic scoring is used, so the highest and lowest scores are dropped. The highest total score will be the winner, next highest will be first runner-up followed by the second runner-up. In case of a tie, the judges will make a final determination.

The first runner-up will assume the title, privileges and responsibilities of the winner in the event the winner is not able to serve, whether on a temporary or permanent basis. The second runner-up will be asked to step up in the event neither the winner or the first runner-up is unable to serve.

Contest Events and Descriptions

Contestants are expected to attend the following weekend events. The location will be Sidewinders Bar unless otherwise noted (Saturday luncheon and Sunday brunch locations TBA)

Description of Scoring Categories

Casual Bear Wear (200 points maximum)

Casual Bear Wear will be worn for the first appearance onstage during the Spontaneous Response. Casual Bear Wear allows the contestant to express himself through what he wears. This would typically be what one wears out to a bar.

Spontaneous Response (200 points maximum)

Two questions (one serious and one whimsical) will be picked by the contestant to be read to the audience and answered onstage by the contestant.

Physique (200 points maximum)

In this audience favorite, contestants will appear in as little as legally possible while the emcee(s) provides commentary based on the information contained in the contestant application form as well as information gleaned throughout the judging process. Contestants will be judged on appearance as well as "stage presence" (in other words, WORK THAT CROWD and WOW the judges')

Leather Bear Image/Speech (300 points maximum)

The Leather Bear Image portion give the contestant the opportunity to appear onstage in something in which he feels comfortable and which represents his leather bear lifestyle. During this portion, the contestant will also give a speech to the judges and audience of no more than 90 seconds. Contestants are encouraged to identify a platform or theme for their title year and use the speech to develop that idea. Appropriateness of topic and depth of discussion will be judged.
